MINUTES REGULAR MEETING 02-22-2022

The regular meeting of the West Valley County Water District was called to order at 7:01 PM. The meeting began with the Pledge of Allegiance.

APPROVAL OF REGULAR MINUTES

The Regular Meeting set for January 25, 2022, was cancelled for lack of quorum. No minutes to approve.

APPROVAL OF FINANCIAL TRANSACTIONS

A motion was made by Director G. Allison to approve the Financial Transactions for December 2021, including checks 8847 – 9911; January 2022, including checks 8868 - 9918. The motion was seconded by Secretary Richmond. The vote was taken and carried with 3 Ayes, 0 Noes and 2 Absent.

He discussed pressure valves as a means of reducing water leaks. He also explained more about the benefits of the backup generator. There were no questions from the Board about the 2022 Updated Rate Study. Secretary B. Richmond questioned the rates of surplus water, which were not mentioned in the Rate Study.
